

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of North Main Street and being known and designated as Lot No. 15 on a plat of Block F, HIGHLAND TERRACE Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book K at Pages 120-122, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of North Main Street at the joint front corner of Lots 15 and 16 and running thence with the common line of said Lots N:66-30 W. 190 feet to an iron pin at the joint rear corner of said Lots; thence S:14-47 W. 77.5 feet to an iron pin in a 15 ft. alley; thence with said alley S.66-30 E. 190 feet to an iron pin on North Main Street; thence with said Street N:14-47 E. 77.5 feet to the point of beginning.
