NOW, KNOW ALL MEN, that Mortgagor (all, & more than one), to secure payment of a Promissory Note of even date from Mortgagor to CIT Financial Services, Inc. (hereafter "Mortgagor") in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagor, in Maximum Outstanding of any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagor, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville

All that certain lot of land on the West side of Webster Street in the village of S.Slater & Sons, Inc., in Bates Township, County and State aforesaid, being lot no. 9 of Block H as shown on a plat recorded in Book E at pages 63, 64 and 65, in the R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Webster Street at the joint corner of Lots 9 and 10 of Block H and thence running with the line of lot no. 10 S. 62-41 W., 123.97 feet to an iron pin at the joint rear corner of Lots 13 and 14; thence with the rear line of Lots 14, S. 6-26 E., 70 feet to an iron pin at joint corner of Lots 8 and 9, 14 and 15; thence with the line of Lot 8, N. 82-41 E., 123.91 feet to an iron pin on the West side of Webster Street; thence with Webster Street, N. 7-19 W., 70 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagor, its successors and assigns forever.

If Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, taxes, assessments, obligations and any charges whatsoever against the above described real estate and all sums due under any prior encumbrances against said real estate. Mortgagor also agrees to maintain insurance on the above described real estate in such form and amount as may be satisfactory to Mortgagor in Mortgagor's favor and in default thereof Mortgagor may, but is not obligated to, effect said insurance in Mortgagor's own name.

If Mortgagor makes an expenditure for any tax, tax, assessment, premium, covenant, prior mortgage or any charge whatsoever in connection with the above described real estate, such expenditure shall bear interest at the highest lawful rate if not prohibited by law, shall be a lien hereunder on the above described real estate, and may be enforced and collected in the same manner as the other debt hereby secured.

Upon any default, all obligations of Mortgagor to Mortgagor shall become due, at the option of Mortgagor, without notice or demand.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be incurred by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagor against Mortgagor on the above described real estate.
