bereby, or if the projecty is otherwise sequired after default, the Merigages as trustee shall apply, at the time of the commencement of such proceedings, or at the time the property is otherwise sequired, the amount then remaining to credit of Mortgagor under (a) of paragraph 2 preceding, as a credit on the interest arcrued and unpaid and the balance to the principal then remaining unpaid on the note secure. Lereby.

- 4. The lieu of this instrument shell remain in full force and effect during any postponement or extension of the time of payment of the indebtedness or any part thereof secured hereby.
- 6. He will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and in default thereof the Martgages may pay the came; and will promptly deliver the official receipts therefor to the Mortgages. If the Mortgages fails to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the Mortgages may pay the same, and all sums so paid shall bear interest at the rate provided for in the principal indebtedness from the date of such advance and shall be secured by this mortgage.

Said note or notes shall be secured hereby on a parity with and as fully as if the advance evidenced thereby were included in the note first described above. Said supplemental note or notes shall bear interest at the rate provided for in the principal indebtedness and shall be payable in approximately equal monthly payments for such period as may be agreed upon by the creditor and debtor. Failing to agree on the maturity, the whole of the sum or sums so advanced shall be due and payable thirty (30) days after demand by the creditor. In no event shall the maturity extend beyond the ultimate maturity of the note first described above.

The Mortgagor walves the benefit of any appraisament have of the faste of South Carolina. Should the Mortgages become a party to any suit involving this mortgage or the title to the premises described herein (excluding legal proceedings instituted for forcedosure or for the collection of the debt secured hereby) all costs and expenses reasonably incurred by the Mortgagos, and a reasonable attorney's fee, shall be secured hereby and shall become due and payable thirty (30) days after demand. Should any legal proceedings be instituted for the forcelosure of this mortgage, or should the debt secured hereby or any part thereof be placed in the lands of an attorney at law for collection by suit or otherwise, all costs and expenses, including continuation of abstract and a reasonable attorney's fee, shall be secured hereby, shall become due and payable immediately or on demand, and may be recovered and collected hereunder.
