C., in Plat Book NN, Page 2, reference to said plat being craved for a metes and bounds description thereof.

ALSO,

All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot 62, Lofty Road., formerly Eisenhower Street, as shown on plat of Piedmont Estates, recorded in the RMC Off for Greenville County, S. C., in Plat Book KK, Page 45, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 62 and 61 and running thence along the joint line of saidlots \$ 25-10 W 194.4 feet to an iron pin; thence running N 64-50 W 60 feet to an iron pin; thence running N 25-10 E 194.4 feet to an iron pin on Lofty Road; thence running along Lofty Road \$ 64-54 E 60 feet to an iron pin, the beginning corner.
