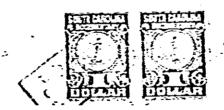

Tidwell, according to a survey made by Dalton & Neves, September, 1952, and having the following metes and bounds, to-wit, according to said survey recorded in the R. K. C. Office for Greenville County in Plat Book BB, at page 33:
