"ALL that certain piece, pircel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 27 acres, more or less, adjoining Paris Mountain State Park and having according to a survey made by W. J. Riddle, Surveyor, April 1, 1937, the following metes and bounds:

BEGINNING at a stake in the center of a road at corner of land now or formerly belonging to Charles M.
