ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of _______, to wit:

Greenville, Chick Springs Township centaining 1.375 Acres and being known as a part of Lot No. 3 according to a plat of the Property of Central Realty Corp. recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Page 143 having, according to a more recent survey made by G. A. Ellis dated December 7, 1946, the following metes and bounts, to-wit:

Beginning at an iron pin, the common corner of Hela Malcolm's lot and running thence N. 26 E. 560 feet to an iron pin on the northeastern side of the lot jointly owned by John Robinson and Myman Robinson and running thence S. 28E. 281 feet to an iron pin and running thence S. 52-304. 155 feet to an iron pin, the point of beginning.

The above is the same property conveyed to the nortgagor by deeds recorded in the R. M. C. Office for Greenville County in Deed Book 302, at Page 435 and Deed Book 303. at Page 338.

This is a first mortgage being second to none:

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the event of the belance owing on the Mortgagee debt, whether due or not.
