## MORTGAGE OF REAL ESTATE

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville , to wit: City of Greenville, Being known and designated as Lot No. 14, Block J, Section 5, East Highkands Estates, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "S", Page 195 and having, according to said plat, the following metes and bounds, To-Wit:

HECHNING at an iron pin on the Southern side of Carolina Avenue, joint front corner of Lots Nos. 13 and 1h, which iron pin is situate 758.1 feet Southwest of the intersection of Carolina Avenue and Laurel Creek Lane; thence along the line of Lot No. 13 S. 19-46 E. 140 feet to an iron pin, joint rear corner of Lots Nos. 13 and 1h; thence S. 87-14 W. 69.6 feet to an iron pin, joint rear corner of Lots Nos. 14 and 15; thence with the line of Lot No. 15 N. 14-0 W. 126.3 feet to an iron pin on the Southern side of Carolina Avenue, Joint Front Corner of Lots Nos. 14 and 15; thence with said Avenue N. 76-34 E. 54.1 feet to the point of beginning.
