All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot Greenville, being known and designated as Lot No. 183 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D at Page 2 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Applejack Lane, joint front corner of Lots 183 and 184, and running thence with the joint line of said lots, S. 77-20 W. 165.4 feet to an iron pin at the rear corner of Lot 180; thence with the line of Lot 180, S. 31-00 E. 78 feet to an iron pin, joint rear corner of Lots 182 and 183; thence with the joint line of said lots, S. 67-36 E. 185.2 feet to an iron pin on the western side of Applejack Lane; thence with the western side of Applejack Lane, N. 17-00 W. 129 feet to an iron pin; thence continuing with Applejack Lane, N. 13-42 W. 51.8 feet to the beginning corner; being the same conveyed to us by Pebble Creek Development, a Partnership by deed of even date, to be recorded herewith.
