To All Whom These Presents May Concern:

ROBERT J. GARVIN AND LUCY J. GARVIN

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty Thousand and

No/100ths Dollars----(\$ 20,000.00_)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not make a provision for esculation of interest rate (paragraphs 9 and 10 of this nortgage provides for an esculation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Sixty-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure since, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may bereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose:

NOW, KNOW ALL MEN. That the Mortzagor, in consideration of said debt and to secure the payment thereof and any further ouns which may be advanced by the Mortzagor to the Mortzagor's account, and also in Consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is lareby acknowledged, has granted, bargain cell, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or let of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot 181, Dumbarton Avenue, Poinsettia Subdivision, Section 4 on plat prepared by Piedmont Engineers and Architects, June 18, 1971 and recorded in the RMC Office for Greenville County in Plat Book 4N at Page 24, which lot is more particularly described in metes and bounds, as follows, to-wit:

BEGINNING at a point on the eastern side of Dumbarton Avenue, the joint front corner of Lots 181 and 182 and running thence along said line S 45-55 E 167.56 feet to a point; running thence S 38-35 W 120 feet to a point, the joint rear corner of Lots 181 and 180; thence along the joint line of said lots N 45-56 W 168.2 feet to a point in Dumbarton Avenue, the joint front corner of Lots 181 and 180; running thence along Dumbarton Avenue N 38-53 E 120 feet to the point of beginning.
