MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

JOHN DAVID SHERBERT

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and sold holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgager's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, Town of Simpsonville, on Cloverdale Court, being shown and designated as Lot No. 167, on plat of Section I, Bellingham, recorded in the RMC Office for Greenville County, S. C., in Plat Book "4 N", at Page 22, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Cloverdale Court, joint front corner of Lots Nos. 166 and 167, and running thence with the joint line of said lots, S. 45-29 E. 155.7 feet to an iron pin; thence S. 55-24 W. 112.9 feet to an iron pin; thence N. 54-02 W. 60.4 feet to an iron pin at rear corner of Lot No. 168; thence with the common line of Lots Nos. 167 and 168, N. 1-00 E. 129.54 feet to an iron pin on the southerly side of Cloverdale Court; thence with Cloverdale Court on a curve, the chord of which is N. 71-18 E. 30 feet to the point of BEGINNING.
