Forty Six Thousand Three Hundred and No/100----- DOLLARS

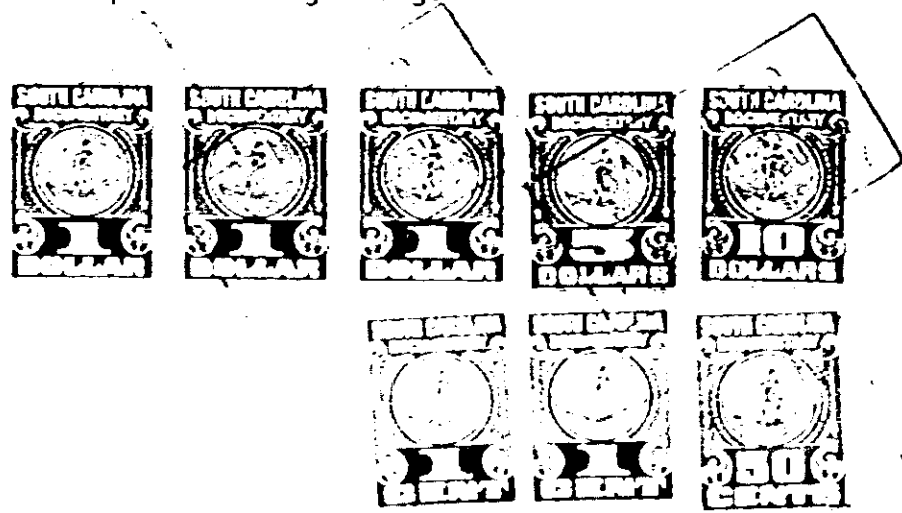

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Swindon Circle, being shown and designated as Lot 137 as shown on a plat of Sec. II, Kingsgate, prepared by Piedmont Engineers and Architects and recorded in the RMC Office for Greenville County in Plat Book 5-D, at Page 23, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the northern side of Swindon Circle at the joint front corner of Lots 137 and 138 and running thence along the common line of said Lots N. 32-00 W. 150.5 feet to a point; thence along the rear lines of Lots 143 and 144 N. 58-15 E. 120.0 feet to a point; thence along the joint line of Lots 136 and 137 S. 32-00 E. 150.0 feet to a point on the northern side of Swindon Circle; thence along the said Swindon Circle S. 58-00 W. 120.0 feet to the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
