For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, Blue Ridge PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Paul C. Aughtry, Jr. and Maryan D. Aughtry to it, on September 15, 19 72, recorded in Mortgage Book 1249, page 349, public records of GREENVILLE County, South Carolina, does hereby release and relinquish the lien of said mortgage

insofar, and so far only, as the same covers and embraces the following described property: ALL that lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 11 on a plat of Nash Mill Estates recorded in Plat Book 4-G at Pg. 163 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the Southwesterly edge of Robin Drive, joint front corner of Lots 11 and 12 and running thence with the edge of said Robin Drive South 37 East 66 ft. to an iron pin; thence still with the curve of said drive, South 48-36 East 66 ft. to an iron pin; thence continuing with the curve of said Robin Drive South 60-12 East 66 ft. to an iron pin at the joint front corner of Lots 10 and 11; thence with the line of Lot 10, South 38-56 West 783 ft. to an iron pin; thence South 80-21 West 190 ft. to an iron pin; thence North 4-55 East 243 ft. to a point; thence North 11-22 East 601.8 ft. to an iron pin; thence with the line of Lot 12 North 66-23 East 174.1 ft. to the point of beginning.
