ALL that certain piece, parcel or lot of land with improvements thereon, in the State of South Carolina, County of Greenville, lying on the north-western side of Edgewood Drive, being shown and designated as Lot No. 57 on a Plat of Kirkwood Heights, prepared by Pickell and Pickell, Engineers, dated October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE at pages 110 and 111 and shown on a more recent plat entitled "Property of Calvin L.
