"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 11 of the property of J. Office for Greenville County, said plat prepared by Piedmont Engineering Service and dated December, 1947, the said lot being more fully described as follows:
