And said montgagor agrees to keep the building and improvements now standing or hereafter errected upon the mertgaged premises and any and all apparatus, futures and appurtenances now or hereafter in or attached to said buildings or injovements insured against loss or damage by fire and such other hizards as the mortgaged may from time to time require, all such insurance to be in forms, in companies and in sums (not less than sufficient to avoid any claim on the part of the insurers for co-insurance) satisfactory to the mortgagee; that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgagee, and that at least fifteen days before the capitation of each such policy, a new and sufficient policy to take the place of the one so expiring shall be delivered to the mortgagee.
