WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of . Two Hundred and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzazee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortzagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose:

NOW, KNOW ALL MEN. That the Mortzazor, in consideration of said debt and to score the payment thereof and any further sums which may be advanced by the Mortzazor to the Mortzazor's account, and also in consideration of the sum of Three Dollars (53:00) to the Mortzazor in hand well and truly paid by the Mortzazor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, barzained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzazoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or kt of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Vine Hill Road, being shown and designated as Lot No. 144 on plat of Pineforest, recorded in the RMC Office for Greenville County in Plat Book QQ, at Pages 106 and 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Vine Hill Road at the joint front corners of Lots Nos. 144 and 143; and running thence with the joint line of said lots, S. 52-25 E. 140 feet to an iron pin; thence S. 37-35 W. 100 feet to an iron pin at the corner of Lot No. 145; thence with the line of Lot No. 145, N. 52-25 W. 150 feet to an iron pin on the southeastern side of Vine Hill Road; thence along Vine Hill Road N. 43-18 E. 100.5 feet to an iron pin at the point of beginning.
