TOCETHER with all and singular the rights, members, hereditaments, and appurtenances to the same Lelenging or in any way incident or appertaining, including all built-in stoves and refrigerators, heating, air conditioning, plumbing and electrical fixtures, wall to wall carpeting, fences and gates, and any other equipment or fixtures now or hereafter attached connected or fitted in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than household furniture. TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute, that the above described premises are free and clear of all liens or other encumbrances; that the Mortgagor is lawfully empowered to convey or encumber the same; and that the Mortgagor will forever defend the said premises unto the Mortgagor, its successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

## THE MORTGAGOR COVENANTS AND AGREES AS FOLLOWS:

- 1. That the Mortgagor will promptly pay the principal and interest on the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- 2. - 3. That Mortgagor will keep the improvements on the mortgaged premises, whether row existing or hereafter to be erected, insured against loss by fire, windstorm and other hazards in a sum not less than the balance due hereunder at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor does hereby assign the policy or policies of insurance to the Mortgagee and agrees that all such policies shall be held by the Mortgagee should it so require and shall include loss payable clauses in favor of the Mortgagee; and in the event of loss, Mortgagor will give immediate notice thereof to the Mortgagee by registered much and should the Mortgagor at any time fail to keep said premises insured or fail to pay the premiums for such insurance, then the Mortgagee may cause such improvements to be insured in the name of the Mortgagor and reimburse itself for the cost of such insurance, with interest as hereinabove provided.

That the Mortzagor will not further encomber the premises above described, without the prior consent of the Mortzagoe, and should the Mortzagor so encomber such premises the Mortzagoe may, at its option, declare the indebtedness hereby secured to be immediately due and payable and may institute any proceedings necessary to collect said indebtedness.
- 9. That should the Mortzazor alienate the mortzazed premises by Contract of Sale, Bord for Title, or Deed of Conveyance, and the within mortgage indebtedness is not paid in full, the Mortzazor or his Furchaser shall be required to file with the Association an application for an assumption of the mortzaze indebtedness, pay the reasonable cost as required by the Association for processing the assumption, furnish the Association with a copy of the Contract of Sale, Bond for Title, or Deed of Conveyance, and have the interest rate on the lain balance existing at the time of transfer modified by increasing the interest rate on the said bun balance to the maximum rate per annum permitted to be charged at that time by applicable South Cardina law, or a loser increase in interest rate as may be determined by the Association. That should the Morteagor ful to make payments of principal and interest as due on the promissory note and the same shall be unpaid for a period of thirty (59) days or if there should be any fudure to comply with and abide by any by-laws or the charter of the Morteagor, or any stipulations set out in this morteage, the Morteagor, at its oft on may write to the Morteagor at his last known address giving him thirty (50) days in which to rectify the said default and should the Morteagor ful to rectify said default within the said thirty days the Morteagor, may at its option, increase the interest rate on the loan bulance for the remaining term of the loan or for a lesser term to the maximum rate per annum permitted to be charged at that time by applicable South Carolina law, or a lesser increase rate as may be determined by the Association. That should the Mortzager fall to make payments of principal and interest is due on the promissory note and should any monthly installment become past due for a period in excess of 15 days, the Mortzager may collect a "late charge" not to exceed an amount equal to five (5%) per centum of any such past due installment in order to cover the extra expense incident to the handling of such delignment naments.
