Vinson and Mildred C. Vinson to it, on May 7, 1975, recorded in Mortgage Book 1338, page 624, public records of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property:
