All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, about 3 miles northwest of the City of Greenville, being Lot 84 of plat made by Dalton and Neves, September, 1915 and recorded in the RMC Office for Greenville County, South Carolina in Plat Book "9", Page 112, and having, according to said plat, the following metes and bounds, to-wit:
