Lender's written agreement or applicable law. Borrower shall pay the amount of all mortgage insurance premiums in the manner provided under paragraph 2 hereof.

Any amounts disbursed by Lender pursuant to this paragraph? with interest thereon shall become additional indebledness of Botrower secured by this Mortgage. Unless Botrower and Lender agree to other terms of payment, such amounts shall be payable upon notice from Lender to Botrower requesting payment thereof, and shall bear interest from the date of disbursement at the rate payable from time to time on outstanding principal under the Note unless payment of interest at such rate would be contrary to applicable law on which event such amounts shall bear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph? Shall require Lender to incur any expense or take any action bereunder.

8. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

9. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for convexance in lieu of condemnation, are bereby assigned and shall be paid to Lender.

In the event of a total taking of the Property, the proceeds shall be applied to the soms secured by this Mortgage, with the excess, if any paid to Borrower. In the event of a partial tolling of the Property colless Borrower and Lender otherwise agree in writing, there shall be applied to the same secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the same secured by this Mortgage immediately prior to the date of taking hears to the fair market value of the Property round ately prior to the date of taking with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Botrower, or if, after notice by Lender to Botrower that the condemnor offers to make an award or settle a claim for damages. Botrower finds to respond to Lender within 30 days after the date such notice is mailed. Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpane the due date of the mouthly installments referred to in paragraphs 1 and 2 hereof or change the amount of such installments.

10. Borrower Not Released. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in interest. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower's successors in interest

II. Forbearance by Lender Not a Waiver. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law shall not be a waiver at or preclude the exercise of any such right or remedy. The procurement of insurance of the payment of taxes of other bens of charges by Lender shall not be a waiver of Lender's right to accelerate the materity of the codebtedness secured by this Mortgage.

12. Remedies Cumulative. All remedies provided on this Mortgage are distinct and complative to any other right or temedy under this Mortgage or afforded by law or court, and may be exercised concurrently independently or successively.

13. Successors and Assigns Bound: Joint and Several Finhility: Captions. The coverants and agreements berein contained shall bind and the rights bereinder shall rate to the respective successors and assigns of Lender and Borrower, subject to the provisions of paragraph 17 bereot. All coverents and agreements of Borrower shall be soint and several. The captions and headings of the paragraphs of this Moragage are for convenience only and are not to be used to interpret or define the provisions bereof.

14. Notice. Except for any notice required under applicable law to be given in another manner. (a) any notice to Bestiever provided for in this Mortgage shall be given by mealing such indice by certified mail addressed to Bostower at the Property Address or at such other address as Bostower may designate by notice to Lender as provided betein, and also any notice to Lender shall be given by certified modified to telephone of Lender's address stated betein or to such other address as Lender may designate by notice to Bostower as provided betein. Any notice provided for in this Mortgage shall be deemed to have been given to Bostower or Lender when given in the manner designated betein.

15. Uniform Mortgage: Governing Laws Severability. This form of mortgage combines uniform covenants for national use and non-uniform covenants with limited variations by proside tion to constitute a uniform security instrument covering real property. This Mortgage shall be governed by the Latter of the constitution of which the Property is located. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of the Mortgage and the Note are declared to be severable.

16. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation bereof.

17. Transfer of the Property: Assumption. If all or any part of the Property or an interest therein is sold or transferred by Borrower without Lender's prior written consent excluding (a) the creation of a lien or encumbrance subordinate to this Mortgage. (b) the creation of a purchase money security interest for biousehold appliances, (c) a transfer by devise, descent or by operation of law upon the death of a soint tenant or (d) the grant of any leasehold interest of three years or less not containing an option to purchase, I ender may at Lender's option declare all the sums secured by this Mortgage to be immediately due and payable. Lender shall have waised such option to accelerate it, prior to the sale or transfer, I ender and the person to whom the Property is to be sold or transferred reach agreement in writing that the credit of such person is satisfactory to I ender and that the interest payable on the soms secured by this Mortgage shall be at such rate as I ender shall request. If I ender has waised the option to accelerate provided in this paragraph 17, and if Borrower's successor in interest has executed a viritten assumption agreement accepted in writing by I ender. Lender shall release Borrower from all obligations under this Mortgage and the Note.

If Lender exercises such option to accelerate I coder shall mail Borrower motice of acceleration in accordance with paragraph 14 hereof. Such notice shall provide a period of not less than 30 days from the date the notice is mailed within which Borrower may pay the sums declared due. It Borrower fails to pay such sums prior to the expiration of such period. Lender may, without further notice or demand on Borrower, mode any temodies permitted by paragraph 18 hereof.

Non-Unitorial Courses is. Borrower and Lender further covenant and agree as follows:

18. Acceleration: Remedies. It scept as provided in paragraph 17 hereod, upon Borrower's breach of any covenant or agreement of Borrower in this Mortgage, including the covenants to pay when due any sums secured by this Mortgage, Lender prior to acceleration shall mail notice to Borrower as provided in paragraph 14 hereof specifying: (1) the breach: (2) the action required to cure such breach; (3) a date, not less than 30 days from the date the notice is mailed to Borrower, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, I ender at Lender's option may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees, and costs of documentary evidence, abstracts and title reports, all of which shall be additional sums secured by this Mortgage.

19. Borrower's Right to Reinstate. Notwithstanding Lender's acceleration of the soms secured by this Mortgage, Borrower shall have the right to have any proceedings begun by Lender to enforce this Mortgage discontinued at any time
