with interest thereon from at the rate of per centum per annum, to be paid:

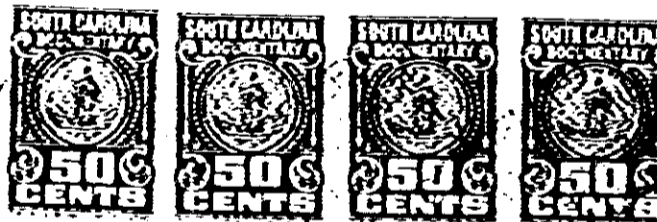

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Being shown and designated as Lot No. 37, on a plat entitled, "STRATTON PLACE", by Piedmont Engineers and Architects dated July 10, 1972, and recorded in Greenville County in Plat Book 4-R, at Pages 36-37, and having, according to said plat such metes and bounds as shown thereon."

The above described property is the same conveyed to the mortgagor by the mortgagee by deed dated June 23, 1976 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 1039, at Page 158.

This is a second mortgage and is junior to the lien of First Federal Savings and Loan Association of Greenville in the sum of \$ 55,000.00.
