"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as portions of Lots 1 and 2, Section B of the property of Alice M. and H. H. Willis as shown upon plat prepared by W. J. Riddle recorded in the Greenville County R.M.C. Office in Plat Book J at pages 150 and 151 and being more specifically described by a plat dated November 2, 1965 by C. O. Riddle entitled "Property of E. J. Wilson".
