

ALL that piece, parcel or lot of land with improvements thereon situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being composed of the Western half of Lots Nos. 4 and 5 of Block B of a subdivision known as Park Place as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book A, at Page 119, and having the following metes and bounds, to-wit:

ALL those pieces, parcels or lots of land, situate, lying and being on the southern side of Alexander Street near the City of Greenville, in Greenville County, South Carolina, being shown and designated as Lots Nos. 1, 2, and 3 on a Plat of the Property of Canton West made by Dalton & Neves, Engineers, dated January, 1927, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H, at Page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of property formerly owned by Samuel Briggs, on the southern side of Alexander Street and running thence with the line of said property, S. 32-20 E. 33 feet to an iron pin; thence N. 57-30 E. 156 feet to an iron pin at the joint rear corners of Lots Nos. 3 and 4; thence with the line of Lot No. 4, N. 32-30 W. 83 feet to an iron pin on Alexander Street; thence with the southern side of Alexander Street, S. 57-30 W. 156 feet to an iron pin at the point of beginning.

P. Landrum on plat thereof made by W. A. Hudson, Surveyor, December 6, 1902, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book A, at Page 120, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on north side of Montgomery Avenue at corner of Lot now or formerly belonging to W. T. Phillips, which point is approximately 313 feet west of the northwest corner of the intersection of Montgomery Avenue and Buncombe Street; and running thence along line of Phillips lot, N. 33-30 W. 100 feet to an iron pin; thence S. 56-30 W. 50 feet to an iron pin at rear corner of lot now or formerly belonging to J. A. Burns; thence along the line of that lot, S. 33-30 E. 100 feet to joint corner of said lots on Montgomery Avenue; thence along north side of said Avenue N. 56-30 E. 50 feet to the point of beginning.
