TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinaster referred to as Mortgagee) in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that lot of land in Greenville County, State of South Carolina, on the southern side of Parliament Road, being shown as Lot 28 on plat of Merrifield Park, Section II, recorded in Plat Book WWW at pages 50 and 51 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

Beginning on the southern side of Parliament Road at the joint front corner of lots nos. 27 and 28 and running thence along the joint line of said lots, S 14-06 W 164.8 feet to an iron pin; thence N 75-58 W 115.0 feet to the joint rear corner of Lots Nos. 28 and 29; thence with the joint line of said lots, N 14-03 E 164.81 feet to an iron pin on Parliament Road; thence with said Road, S 75-55 E 115.0 feet to an iron pin at the point of beginning.
