TO ALL WHOM THESE PRESENTS MAY CONCERN: ASSOCIATED BUILDERS & DEVELOPERS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY NINE THOUSAND TWO HUNDRED FIFTY AND NO/100 ----- DOLLARS

(\$ 29,250.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

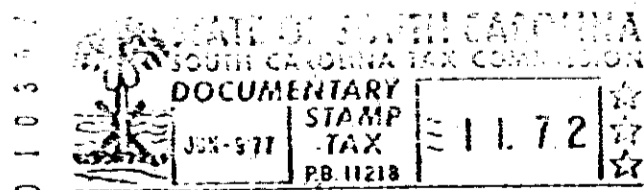

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of of Menlo Drive, in the City of Simpsonville, being shown and designated as Lot No. 125 on a plat of BRENTWOOD, SECTION III, made by Piedmont Engineers, Architects & Planners, Surveyors, dated November 15, 1973, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 5-D at page 42, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Menlo Drive at the joint front corners of Lots Nos. 124 and 125, and running thence along the common line of said lots, N. 54-00 E., 154.53 feet to an iron pin; thence N. 36-00 W., 105 feet to an iron pin at the joint rear corners of Lots Nos. 125 and 126; thence with the common line of said lots, S. 54-00 W., 155 feet to an iron pin on Menlo Drive; thence with the eastern side of Menlo Drive, S. 36-00 E., 105 feet to an iron pin, the point of BEGINNING.

The above described property is the same conveyed to the mortgagor herein by deed of Rackley, Builder-Developer, Inc., to be recorded herewith.
