

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 97 on plat of Sections 1 and 2, Belle Meade, which plat if recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, at page 95, and according to a more recent survey prepared by Carolina Surveying Co., dated September 27, 1977, being known as Property of Calvin Griffin and Raymond Griffin, Jr., recorded in the RMC Office for Greenville County, S. C., in Plat Book 6-I, at page 48, and having, according to said plat the following metes and bounds, to-wit:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
