

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 82 on a plat of Cedar Lane Gardens recorded in the RMC Office for Greenville County in Plat Book GG at page 139, and on a more recent plat of property of Earl D. Keller by Carolina Surveying Co., dated May 20th, 1971, and having the following metes and bounds and courses and distances, to wit:
