with interest thereon from DATE at the rate of NINE(9%) per centum per annum, to be paid: MONTHLY.

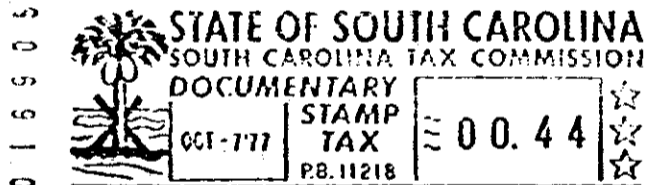

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being in the City of Greenville and being known and designated as Lot Nos. 38 and 39, Block B of Jefferson Heights, according to Plat Book C at Pages 34 and 35 in the RMC Office for Greenville County. Each lot fronts 25.5 feet with a depth of 87.5 feet, and has the courses and distances shown on said plat.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
