K. Campbell Surveyor dated March 1954 recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book GG at page 35, reference to which is hereby craved for the metes and bounds thereof.

The above described property is the same conveyed to the mortgagors herein by deed of James B. McCall, individually and as Executor of the Estate of Clara B. McCall, deceased, C. O. McCall and Henry Y. Simmons, to be recorded herewith.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
