All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northeast side of Maco Street, being known and designated as a portion of Lot No. 77 on plat of Eastover, recorded in the RMC Office for Greenville County in Plat Book F, at Pages 41 and 42, and having, according to a new survey entitled "Property of C. E. Sloan and Betty O. Sloan" prepared by Dalton & Neves, Engineers, November 1962, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Maco Street, joint corner of Lots 77 and 69, and running thence along the northeast side of Maco Street, N. 36-10 W. 61 feet to an iron pin, joint corner of Lots 77, 80 and 79; thence N. 64-30 E. 169.5 feet to an iron pin, thence S. 25-30 E. 60 feet to an iron pin; thence S. 64-30 W. 158.5 feet to an iron pin on the northeast side of Maco Street, the point of BEGINNING.
