

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being located on the eastern side of Lavinia Avenue and known and designated as Lot No. 25 according to a plat of Property of Rowley Place made by W. A. Adams, Engineer, and recorded in the R.M.C. Office for Greenville County in Plat Book C, Page 5, and being more particularly described according to a plat made by Pickell & Pickell, Engineers, October 4, 1944, as follows:

BEGINNING at a stake on the eastern side of Lavinia Avenue at the joint front corner of Lots Nos. 25 and 26 and running thence with the line of said lots N. 78-45 E. 155 feet to a stake on a 10 foot alley; thence with the alley S. 19-30 E. 55 feet to a stake; thence with the line of Lot No. 24 S. 78-45 W. 155 feet to a stake on the eastern side of Lavinia Avenue; thence with Lavinia Avenue N. 19-30 W. 55 feet to the beginning corner.

This being the same property as conveyed to the Mortgagor by deed of Kathleen La Belle and Carroll B. Long and recorded in the R.M.C. Office for Greenville County on April 15, 1970.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
