All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Batesview Drive,

in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 19 on the plat of Northside Gardens, recorded in Plat Book S at Page 17, and having, according to said plat, the following metes and bounds, to-wit:
