MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hard well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Pimlico Road, and being shown as the major portion of Lot 31 on a plat of Gower Estates, Section A, recorded in Plat Book QQ, pages 146 and 147, and being more particularly shown on plat of property of E. J. McCarty prepared by J. C. Hill, and dated October 4, 1961, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Pimlico Road, the joint front corner of Lots 31 and 32, which pin is 191.6 feet south of the intersection of said Road with Carolina Avenue; thence with the northwest side of Pimlico Road, S. 13-19 W. 93 feet to an iron pin; thence with said road, S. 27-43 W. 54.8 feet to an iron pin; thence continuing with said road, S. 56-23 W. 54.8 feet to an iron pin 30 feet from the original joint front corner of Lots 30 and 31; thence N. 70-46 E. 74 feet to an iron pin in line of Lot 32; thence S. 77-21 E. 82.7 feet to the beginning corner.
