WHEREAS, the Mortgagor is well and truly indebted unto Cameron-Brown Company

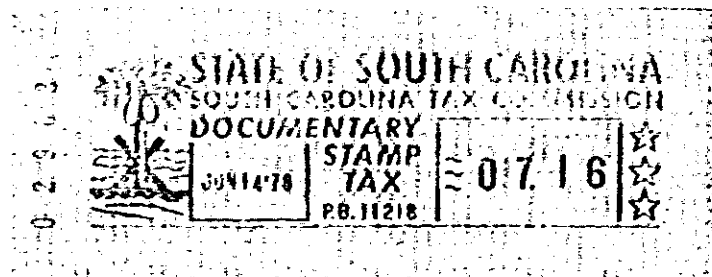

Dollars (\$ 17,900.00), with interest from date at the rate
of Nine per centum (9 %) per annum until paid, said principal

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mort-
gagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the
receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real
estate situated in the County of Greenville
State of South Carolina:

ALL that piece, parcel or lot of land in Greenville Township, Greenville
County, State of South Carolina, situate, lying and being near the corporate
limits of the City of Greenville, near the Laurens Road and on the East
side of Underwood Avenue and being known and designated as Lot No. 39 of
Glenn Grove Park, as shown on plat of same property prepared by R. E.
Dalton, Engineer, in May, 1924 with said plat being recorded in the RMC
Office for Greenville County in Plat Book "F", at Page 233, reference
to which is hereby craved for the metes and bounds description.

This being the same property conveyed to mortgagor by deed of Lillian D.
D. Skinner Myers, dated June 12, 1978 and recorded in the RMC Office for
Greenville County, S.C., in Deed Book 1081 at Page 169.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in
any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom,
and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in
connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns
forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
solute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises
are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and for-
ever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all per-
sons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at
the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal
to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior
to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty
(30) days prior to prepayment.
