That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 50 as shown on a plat of "Rosedale", revised May and June, 1960, prepared by C. O. Riddle, R.L.S., recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 113, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern edge of Rosemary Lane at the joint front corner of Lots Nos. 49 and 50 and running thence with the Southern edge of Rosemary Lane S. 73-52 E. 110 feet to an iron pin; thence S. 16-08 W. 140 feet to an iron pin; thence S. 61-08 W. 14.1 feet to an iron pin; thence N. 73-52 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 49 and 50; thence with the line of Lot No. 49 N. 16-08 E. 150 feet to the point of beginning.

ALSO: All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as a portion of Lot No. 51 as shown on a plat of "Rosedale", revised May and June, 1960, prepared by C. O. Riddle, R.L.S., recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 113, and having according to a more recent plat prepared by C.O. Roddle, R.L.S., revised June 15, 1963, entitled "Revised Map, Lots 51, 52 & 53, Rosedale", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book WW at page 503, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Rosemary Lane at the joint front corner of Lots Nos. 50 and 51, and running thence with the line of Lot No. 50 S. 16-08 W. 72 feet to an iron pin; thence N. 75-04 E. 36.2 feet to an iron pin in the center of a creek; thence N. 3-33 W. up the center of said creed 46.5 feet to an iron pin in said creek; thence N. 42-09 W. 18 feet to the point of beginning.
