

ALL that lot of land with the buildings and improvements thereon situate on the west side of West Dorchester Boulevard near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 166 on Plat of Belle Meade Subdivision made by Piedmont Engineering Service, July, 1954, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG, page 95, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of West Dorchestor Boulevard at the joint front corner of Lots 165 and 166 and runs thence along the line of Lot 165, S. 83-16 W. 150 feet to an iron pin; thence N. 6-44 W. 70 feet to an iron pin; thence with the line of Lot 167 N. 83-16 E. 150 feet to an iron pin on the west side of West Dorchester Boulevard; thence along West Dorchester Boulevard, S. 6-44 E. 70 feet to the beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagce, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
