June 1, 2008, and

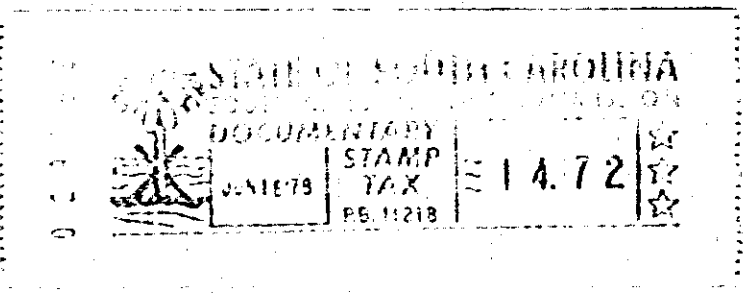
