
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 30 on plat of Coral Ridge recorded in Plat Book XX at page 119 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an Iron pin on Coral Drive at the joint front corner of Lots 29 and 30; thence S 86-37 E 165.1 feet to an Iron pin; thence N 13-24 E 90.1 feet to an Iron pin at corner of Lot 32; thence with line of lots 31 and 32, N 86-10 W 180 feet to an Iron pin on Coral Drive; thence with said Drive, S 3-50 W 90 feet to the beginning corner.
