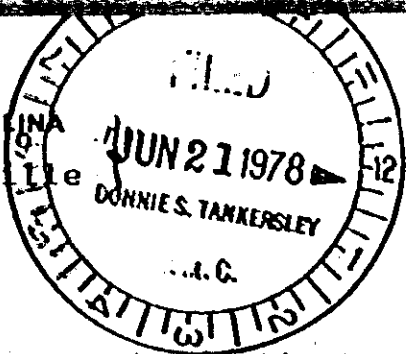

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, we, the said Willie Mae Dreher and Christopher C. Dreher
(hereinafter referred to as Mortgagor) is well and truly indebted unto Pickensville Finance Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three thousand eight hundred eighty-eight and no/100 Dollars (\$ 3,888.00--) due and payable

in 36 successive monthly payments of One hundred eight and no/100(\$108.00)Dollars per month beginning July 25, 1978 and due each and every 25th. thereafter until the entire amount is paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, just outside the city limits of the City of Greenville on the corner of Lafayette and Greene, known and designated as Lot No. 22 as is shown by plat recorded in the R.M.C. Office for Greenville County in Plat Book "F" at page 54, having a frontage of 35 feet on Lafayette Street and running back in parallel line with Greene Avenue 100.feet.

This is the property shown as tract 4 on deed to Marie Dreher, as trustee recorded in the R.M.C. Office for Greenville County in Deed Book 676 at Page 421.

This is the identical property conveyed to Christopher C. Dreher and Willie Mae Dreher by Marie Dreher as trustee by deed dated March 25, 1968 and recorded in Book 840 of Deeds, page 218 in the Office of the Register of Mesne Conveyance for Greenville County, South Carolina.
