"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the southeastern side of Vesta Drive, being shown and designated as 1ot No. 84 on a Plat of VardryVale, Section 2, made by Campbell and Clarkson, Surveyors, dated March 17, 1969 and recorded in the RMC Office of Greenville County, S.C. in Plat Book WWW at page 53 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of the cul-de-sac of Vesta Drive at the joint front corner of Lots No. 84 and 85 and running thence S. 50-52 E., 129 feet to an iron pin; thence S. 39-08 W., 110 feet to an iron pin; thence N. 37-52 W. 153.95 feet to an iron pin on Vesta Drive; thence with Vesta Drive, N. 39-08 E., 13.5 feet to an iron pin; thence with the curve of the cul-de-sac of Vesta Drive, N. 76-01 E., 40 feet to an iron pin and N. 33-50 E., 32.5 feet to an iron pin, the beginning corner.

This is the same property conveyed to the grantors by Deed recorded in the RMC Office of Greenville County in Deed Book 882 at page 13.


This conveyance is subject to restrictive covenants of record, set back lines, road or passageways, easements and rights of way, if any, affecting the above described property.
