MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, MARTHA R. MOORE

(hereinafter referred to as Mortgagor) is well and truly indebted unto

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

FIFTEEN THOUSAND Dollars (\$ 15,000 ) due and payable  
in 120 equal, consecutive monthly installments of \$215.21, beginning  
July 1, 1980, and continuing on the same date of each succeeding  
month thereafter until paid in full,

with interest thereon from date at the rate of 12% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, being shown and designated as Lot 46 on a Plat of WOODHEDGE Subdivision, recorded in the RMC Office for Greenville County in Plat Book 5-D, at Page 58, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on Arrowood Court, joint front corner of Lots 45 and 46, and running thence with the common line of said Lots, N 43-44 E, 150.49 feet to an iron pin in a branch; thence running with the branch as the line, having the following courses and distances, to wit: S 37-48 E, 70.7 feet; thence S 88-35 E, 55 feet; thence S 41-54 E, 96.28 feet to an iron pin; thence S 43-43 W, 95.4 feet; thence S 76-11 E, 187.38 feet to an iron pin on Arrowood Court at the joint front corner of Lots 46 and 47; running thence with the curve of Arrowood Court, N 23-10 W, 4805 feet to the point of beginning.
