NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 1 on plat of Pinehurst, recorded in Plat B ook PP, at Page 39, and having such courses and distances as will appear by reference to said plat.

This conveyance is subject to all rights-of-way, easements and protective covenants affecting same appearing upon the public records of Greenville County and/or on the premises.

This is the same property conveyed to the grantors herein by deed of Norris D. King and Nancy F. King dated September 16, 1977, and recorded in the RMC. Office of Greenville County, S. C., in Deed Book 1065, as Page 14.

As part of the consideration herefor, the grantees herein assume and agree to pay that certain real estate mortgage given by the grantors to Fidelity Federal Savings and Loan Association on S eptember 16, 1977, as recorded in the RMC Office for Greenville County, S. C. in REM Book 1410, at Page 204, on which there is a present balance of \$34,244.96.
