MORTGAGE

THIS MORTGAGE is made this 13th day of October,
19 80, between the Mortgagor, Sara Jo Stewart

(herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventeen thousand and no/100ths (\$17,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated October 13, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November 1st, 2002.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon or hereafter to be constructed, situate, lying and being in the County of Greenville, State of South Carolina on Spinnaker Court, shown and designated as Unit No. 5 on plat of Harbor Town, recorded in the RMC Office for Greenville County, S. C., in Plat Book 5P at Pages 13 and 14, and being described more particularly by a more recent plat for Sara Jo Stewart, prepared by Carolina Surveying Company, dated October 10, 1980, as follows:

BEGINNING at a point at the joint corner of Units 5 and 6 and thence running S. 38-50 W. 17 feet; thence turning and running N. 51-10 W. 68.6 feet; thence turning and running N. 38-50 E. 17 feet; thence turning and running S. 51-10 E. 68.6 feet to the point of beginning.

THIS being the same property conveyed to the Mortgagor herein by deed of F. Gary Skinner, dated October 13, 1980, and recorded in the RMC Office for Greenville County, S. C., in Deed Book 1135 at Page 432 on October 14, 1980.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
