RIDER TO MORTGAGE OF TANGLEWOOD BAPITST CHURCH TO HOME SAVINGS

AND LOAN ASSOCIATION (CONT.)

ALSO: ALL that piece, parcel or lot of land, situate, lying and being on the western side of Julian Avenue near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot Nos. 23, 24, 25, and 26, as shown on a plat of the Estate of J. BEGINNING at an iron pin on the westerly side of Julian Avenue, which iron pin is located 236.5 feet in a southeasterly direction from the intersection of New Dunham Bridge Road and Julian Avenue at the joint corner of Lots Nos. 1 and 2, and running thence with the line of Lot No. 1 S. 52-30 W. 305 feet to an iron pin on the Fasterly side of the New Dunham Bridge Road at the joint corner of Lots Nos. 22 and 23 as shown on the first above mentioned plat; thence with the line of property now or formerly of Otis Orr S. 83-08 E. 149.6 feet to an iron pin at the joint corner of Lots Nos. 2 and 3; thence with the line of Lot No. 3 N. 55-30 E. 185 feet to an iron pin on the Westerly side of Julian Avenue; thence with the Westerly side of Julian Avenue N. 31-05 W. 115 feet to the point of beginning.
