TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE, made this 14th day of August, 1981, by George Kendrick Clardy, Jr. and Sylvia Waller Clardy hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

ALL that certain piece, parcel or lot of land located in the County of Greenville, State of South Carolina, and being known and designated as Lot 129, according to a plat entitled "Heritage Lakes Subdivision" by Heaner Engineering Co., Inc., as revised October 26, 1977, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 6-H, at Page 19. Reference is hereby made to said plat for a metes and bounds description.

This is the same property conveyed to the Mortgagors herein by deed of Cobb Builders, Inc., dated July 30, 1980, and recorded in the RMC Office for Greenville County, S. C. in Deed Book 1130, at Page 87, on July 31, 1980.
