To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that tract or lot of land in Butler Township, Greenville County, State of South Carolina, on the southeast side of Halton Road, and being the Southwestern portion of Lot No. 11 of a subdivision known as Happy Valley Farms, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book "0" at page 103, and having the following metes and bounds, to-wit: Beginning at an iron pin on the southeast side of Halton Road, which pin is 165.1 feet from the intersection of said road and county road, and running thence with said Halton Road, N. 33-22 E. 75 feet to a corner; thence S 56-30 E. 225.75 feet to a corner; thence S. 33-30 W. 75 feet to an iron pin; thence N. 56-30 W. 225.6 feet to the beginning corner, and being designated as Lot No. 100 on a plat of E.H. Burns property made by Dalton & Neves, August 1951, in a revision plat of Lot 11 and part of Lot 12 on Happy Valley Farms.
