All that certain piece, parcel or lot of land with all improvements thereon, or hereafter to be constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, in Dunklin Township, and being described as follows:

BEGINNING at a point in the center of U.S. Highway No. 25, and going to Mr. Williams (Formerly Johnny Woods) corner; running thence N. 39-30 E 210 feet to an iron pin; thence S. 30-44 E. 210 feet to an iron pin; thence S. 39-30 W. 210 feet to a point in center of U.S. Highway No. 25; thence north 30-44 W. 210 feet to the beginning corner, containing one (1.00) acre, more or less, as per survey and plat made by J. Coke Smith & Son, Dec. 5th, 1955 to which reference is hereby made, bounded on the north by Mr. Williams (Formerly Johnny Woods) and J. D. Huff, on the east by J. D. The amount you pay will be due and payable to you on demand, will bear interest at the highest lawful rate, will be an additional lien on the real estate and may be enforced and collected in the same manner as any other obligation secured by this mortgage.

If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

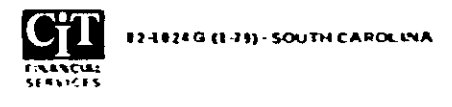
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
