- at its option, foreclose this mortgage for any portion of the debt or any other sums secured thereby which are then due and payable, subject to the continuing lies of this mortgage for the balance not then due, but nothing in this Article contained shall impair or affect any right or ready which the Hortgage might now or hereafter have, were it not for this Article, but the right herein given shall be in addition to any others which the Hortgages may have hereunder.

The Mortgages in any action to foreclose this nortgage, or upon the actual or threatened waste to any part of the premises, or upon default in the observance or performance of any covenant or agreement of the Hoxtgagor hereunder, shall be at liberty to apply for the appointment of a receiver of the ronts and profits of the premises without notice, and shall be entitled to the appointment of such a receiver as a matter of right, without consideration
