being on the south side of Lee Road and the western side of Cardinal Drive between Taylors and Greenville, Chick Springs Towhship and being shown on a plat of Luis F. Moreno, dated August 18, 1982 made by Robert R. Spearman, said plat being recorded in the RMC Office for Greenville County in Plat Book 4G, at Page 53 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern corner of the junction of Lee Road and Cardinal Drive and running thence along Cardinal Drive S. 24-58 E., 188.6 feet to a point; turning thence and running with the joint line of other property owned by Luis F. TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever. The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has

good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of an interest on the indebtedness evidenced by the said note, at the times and in the manner herein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
